CIRCULAR

The orders regarding encashment of earned leave at the time of availing Leave Travel Concession have been issued vide Finance Department, Government Resolutions dated 15-01-2010 and 02-02-2012 mentioned above. With reference to the GR dated 02-02-2012. Many Administrative Departments have made references to this department seeking clarification whether a government employee who has availed LTC after 15-1-2010 but not claimed encashment of earned leave at that time, is entitled for encashment of earned leave in the light of the provisions of the GR dated 02-02-2012.

It is clarified that the employees who have availed LTC after the issuance of the Finance Department-Government Resolution dated 15-01-2010 are entitled for encashment of earned leave under the provisions of the GR dated 02-02-2012 even if they had not claimed encashment at the time of availing LTC.
